1 INTRODUCTION

The Ministry of Finance of The People's Republic of China (MOF) has received a Soft Loan from the Italian Ministry of Foreign Affairs/Directorate-General for Development Cooperation (DGCS) in Euro, towards the cost of Sichuan 10 Hospitals Medical Equipment Procurement Project. It is intended that part of the proceeds of this Soft Loan will be applied to eligible payments under the contract The Training and Hospital Information system Component.

2 TENDERING SUBJECT
